Purchased in 1966 totally dismantled and in very bad condition,

Restoration of Body and all mechanicals completed, awaiting Top and Upholstery (January 2006)

2. Remains owned by myself. ex R. Arnold

Purchased in 1967 this complete mechanical chassis was buried up to the top of the Chassis rails in a garden, the only parts that were able to be saved were the Differential, the gears from the gear box, the cylinder block, pistons, connecting rods, camshaft and crankshaft.

3. Inherited when I purchased No1. This was sold to J. Scott to be used for parts for an Australian Lincoln

4. Remains owned by myself.

This was complete except for the back half of the body when purchased by
